**NOTIFICATION OF UTILITY COMPANIES:**

State law requires the notification to owners or operators any underground utility facilities of excavation at least 48 hours but not more than 14 days before any excavation. Applicant must submit copy of letter(s) sent or to be sent to utility companies and must inform City Engineer or Designee.

## **CHAPTER 150: BUILDING REGULATIONS**

### **FILLING OF OPENINGS:**

On completion of demolition, the site shall be necessary with clean soil, cinders or other inorganic material and graded to a level not lower than nor more than twelve (12) inches above the legal of sidewalks, alleys or adjoining property with proper allowance for settlement.

### **DEBRIS:**

Debris caused from the demolition of a building or structure in excess of that required to fill openings as provided in above paragraph shall be removed from the site as wrecking progresses. No salvaged material shall be left on the premises.

### **PENALTY:**

Any person, firm or corporation violating any of the provisions of this ordinance shall be fined according to the Uniform Fine Schedule in § 10.99 of the city code.
