1. The proper fee must accompany this application. The normal connection fee is \$1,200.00. South of the Illinois River \$1,500 fee. Certain sanitary sewers were constructed by special assessment, in which case a higher fee may be required. Please contact City Hall before submitting this application for the appropriate fee.
2. A sketch must be attached showing lot lines, existing sewer main, and location of desired service with dimensions to lot lines.
3. The property owner/contractor is required to excavate and expose the existing sanitary Sewer and is responsible for the cost to repair any damage to the existing main sewer Caused by the excavation. If excavation of any part of city street is needed, a separate Road excavation permit is required.
4. The City will furnish the labor and materials to tap the sanitary sewer. The property

owner/contractor shall be required to install the service line from the sewer tap to the property line.

5. The City must be notified before any work is commenced and 1 week notice must be given for the tap of the sanitary sewer.
6. The new sewer line to the city main sewer must be inspected and approved before Any backfilling is done.
7. The property owner/contractor is required to provide and place an appropriate backfill over the service line and tap and make all proper street repairs as per road excavation permit, which shall meet the approval of the City.
8. The property owner/contractor shall properly protect the work area, provide any needed traffic control, and provide the City with a certificate of insurance naming the City of Marseilles as an additional named insured for all work covered under this application.
9. This application is conditioned on the premise that a properly sized sanitary sewer is available in front of or adjacent to the property to be sewed. Approval of this application is not to be construed that the city will extend a sanitary sewer to service the property. Sanitary sewer extension fees and costs will be negotiated on a case by case basis.
