1. A \$1,200.00 fee is required for a 3/4" connection and must accompany this application. South of the Illinois River \$1,500 fee.  
For service sizes other than 3/4", please contact City Hall for the appropriate fee. If streets must be excavated road excavation permit is required.
2. A sketch must be attached to this application showing lot lines, existing water main, and the location of the desired service with dimensions to the lot lines.
3. The City will furnish the labor and materials to tap the water main, install the requested size service line and install a shutoff valve and box at the street right of way line.
4. The City must be notified before any work is commenced and 1 week notice must be given for the tap of the water main.

5. The property owner/contractor is required to provide and place an appropriate backfill over the service line from the shut off to the house. The trench depth should be 4.6 feet minimum.
  
6. The property owner/contractor shall properly protect the work area, provide any sidewalk control and provide the City with a certificate of insurance naming the City of Marseilles as an additional named insured for all work covered under this application.
  
7. This application is conditioned on the premise that a properly sized water main is available in front of or adjacent to the property to be sewed. Approval of this application is not to be construed that the City will extend a water main to service the property. Water main extension fees and costs will be negotiated on a case by case basis.
